Mandeville Middle School's After School Care Program will begin **Monday, September 14, 2020**. **There will be no After Care on the first four days of school, Tuesday-Friday, September 8-11, 2020. Due to COVID restrictions, the attached emergency card with September payment is due in order to have a space for your child.** Parents should pick up their children at the north end parking lot by the gym no later than 6:00 p.m.

After Care Payment:

Payment is due the first of each month. Tuition is \$10.00 per day. Families with more than one child attending after care will be charged \$6 for each additional child. Checks should be made payable to MMS After Care or make payment online at *MyPaymentsPlus* under the Child Care tab. **Online payments are strongly encouraged.** Monthly bills will not be sent home.

Drop-In attendance fees are due and payable on the day attended. Please send a note or call the school on the day your child will attend aftercare as a "drop-in" to confirm there is space available.

There is a \$6 fee for attendance following after school activities. This fee must be paid separately from the regular after care fee.
